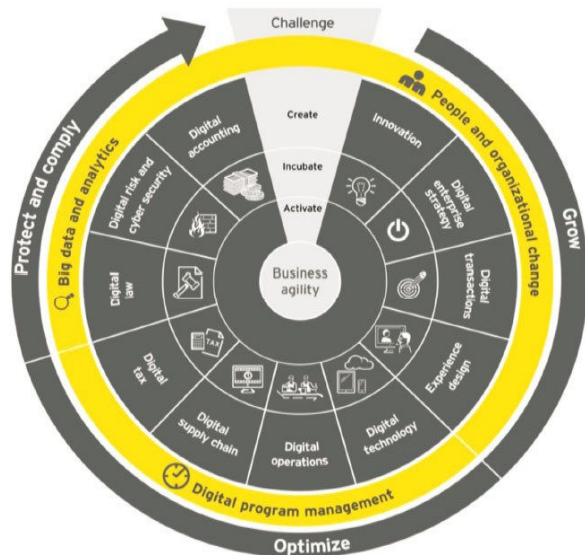

All Tables and figures should be numbered and should be appeared in corresponding text with captions. Source should be explicitly mentioned at the bottom of the table/figure. Footnotes: The superscript numerals should be used for footnote.

3. Abstract and full paper must be sent as a hard copy as well as a soft copy in MS-Word. Papers presenters shall bring the hard copy of the paper on the day seminar.

All submitted papers are peer reviewed & Reviewer's opinion is final.

IMPORTANT DATES:

Abstract of the paper should reach on or before 22.3.2017. Acceptance for publication will be informed before 25.3-2017. Full paper should reach on or before 3.4.2017

Accepted papers will be published in an edited book with ISBN number. Confirmation of registration for participation in the seminar should be conveyed on or before 5. 4. 2017.
