In continuation to this University notice No. BPUT / Exam / 20870 / 2017 dated 05.05.2017, it is for the information of all Principal / Director of Constituent and affiliated College vis-à-vis Teachers registered under the University, that the University has commenced 1st Phase of e-Evaluation of Final Year End Semester (Regular) and their Back Papers in 20 (Twenty) e-Evaluation Nodal Centres from 05.05.2017 in order to publish the results in time.

It is reported that mails sent to teachers empanelled as Assistant Examiner from mail id: evaluation@bput.ac.in to participate in the 1st Phase of evaluation in their allotted Nodal Centre's are not delivered, but delivered in their Principal Log.in ids. In this connection, the respective continuing teachers are requested to re-check their status in BPUT portal www.bputodisha.in for teacher registration, and in www.bputevaluation.com portal for ongoing e-evaluation.

It is also reported that the Principal / Director upon receipt of mail (s) from mail id: evaluation@bput.ac.in about their teachers appointment as Assistant Examiners, have not yet intimated and relieved them to participate in the 1st Phase of e-evaluation.

In view, all the Principal / Director's of Constituent and Affiliated Colleges are hereby informed and requested to instantly relieve their Teachers who have been appointed as Assistant Examiners, cooperate, comply, and send a mail wherever necessary in the event;

- a) If their eligible teacher (s) who have uploaded their faculty data in the portals www.bputodisha.in for teacher registration and in www.bputevaluation.com for evaluation and have not received the intimation to participate in the 1st Phase e-Evaluation to dydir.exam@bput.ac.in ddir.exam1@bput.ac.in dir.exam@bput.ac.in for necessary allocation.
- b) If their existing and newly inducted eligible teachers have not uploaded their faculty data afresh in terms of the Notice No. BPUT / EXAM / 20733 / 2017 dated 29.04.2017 regarding Up-To-Date Data of Continuing Member Faculties of Constituent and Affiliated Colleges under BPUT in the www.bputodisha.in for teacher registration and in www.bputevaluation.com portal for evaluation, upload immediately on Top Priority.

- d) If they have received any intimation from Government Superannuated Teachers served under this University, take approval through the Coordinator, and inform the System Engineer to install the software in their Personal Computer / Lap Top, and allow them to participate in the e-valuation.
- e) If they notice, that the scheme of evaluation have not been provided / prepared, take all suitable steps to involve senior member faculties serving in the College, and provide the Assistant Examiners to evaluate their permitted Subjects forthwith on Top Priority.
