#### MSME Clause

Micro and Small Enterprises (MSEs) registered with National Small Industries Corporation (NSIC) or with any other designated authority of GoI under the Public Procurement Policy for MSEs are exempted from submission of fee towards the cost of Bidding Documents and submission of EMD as per the Provisions of Public Procurement Policy for Micro and Small Enterprises (MSEs) order 2012. This shall be subject to production of documentary evidence with regard to registration with authorities mentioned above.

#### • Bidder/OEM Eligibility Clause

- a) Minimum 5 years presence in Eastern India with local sales and support office. OEM should have at least 5 entries in each of the Top 100 Supercomputers listing (<a href="http://topsc.cdacb.in">http://topsc.cdacb.in</a>) published by CDAC between June 2018 and Jan 2020 indicating consistent presence.
- b) Minimum 3 years presence as a leading provider of High Performance Computing systems worldwide. OEM should have at least five entries in each of the Top 500 Supercomputers listing (<a href="https://www.top500.org/lists/">https://www.top500.org/lists/</a>) published between June 2017 and January 2020 indicating consistent presence in High Performance Computing.
- c) The product series quoted should have been supplied to at least three organizations in India in the last two financial years combined i.e. FY 2016-17 and FY 2017-18.
- d) Financial Capacity: Bidder must be a profit-making entity for the last five years and the bidders should have the minimum annual turnover of Rupees 50 crore during the last three financial years (2015-16, 2016-17, 2017-18). Relevant proof for supporting the above shall be submitted failing which the same shall be treated as void. The firms must be willing and/or capable to invest on minimum three month's expenses before being reimbursed the claim.
- e) ISO Certification: The bidder should have the valid ISO 9001:2015, ISO/IEC 27001:2013, ISO/IEC 20000-1:2011 or 20000-11:2015 certification in management of Information Security for IT Infrastructure Services. Related documents must be produced.
- f) The bidder must have established office/support center in Eastern India.
- g) Bidder should have minimum 80 no's of manpower of their own payroll across India. The PF document of any month of current financial year must be produced as proof.

#### Manpower Clause (Optional)

One engineer with minimum qualification of diploma in electronics or computer science with minimum one year of experience should be deputed at BPUT premises for taking care of HPC system.

The above corrections may be noted. However, other terms and conditions will remain the same
